

## **DIRECTIONS TO LAW OFFICES OF ALAN S. GOLDBERGER**

### **From Garden State Parkway North:**

Take Parkway North to Exit 145 to Route 280 West. Take Route 280 to Exit 4A for Eisenhower Parkway/Chatham. Stay on Eisenhower Parkway for approximately 5 miles to South Orange Avenue traffic light (just past Livingston Mall on left). Turn right on to South Orange Avenue (Route 510). South Orange Avenue becomes Columbia Turnpike. Proceed for approximately 1 ¼ miles to traffic light at Fernwood Drive. Turn RIGHT onto Fernwood Drive and proceed to 30 Columbia Turnpike. Look for first building on right.

### **From Garden State Parkway South**

Take Parkway South to Exit 159 to Route 80 West. Take Route 80 to Exit 43A for Route 287 South/Morristown. Stay on Route 287 to Exit 37 for Route 24 East. Then take Exit 2B for Florham Park. Continue on Columbia Turnpike for approximately 3 miles. Turn left onto Fernwood Drive and proceed to 30 Columbia Turnpike. Look for first building on right.

### **From Route 280 East or West**

Take Route 280 to Exit 4A for Eisenhower Parkway/Chatham. Stay on Eisenhower Parkway for approximately 5 miles to South Orange Avenue traffic light (just past Livingston Mall on left). Turn right on to South Orange Avenue (Route 510). South Orange Avenue becomes Columbia Turnpike. Proceed for approximately 1 ¼ miles to traffic light at Fernwood Drive. Turn RIGHT onto Fernwood Drive and proceed to 30 Columbia Turnpike. Look for first building on right.

### **From Route 80 East or West**

Take Route 80 to Exit 43A for Route 287 South/Morristown. Stay on Route 287 to Exit 37 for Route 24 East. Then take Exit 2B for Florham Park. Continue on Columbia Turnpike for approximately 3 miles. Turn left onto Fernwood Drive and proceed to 30 Columbia Turnpike. Look for first building on right.

### **From 287 North or South**

Take 287 North or South to Exit 37 for Route 24 East/Springfield. Then take Exit 2B for Florham Park. Continue on Columbia Turnpike for approximately 3 miles. Turn left onto Fernwood Drive and proceed to 30 Columbia Turnpike. Look for first building on right.

### **From Route 78 West**

Take Route 78 West to Exit 7 for Route 24 West to Exit for JFK Parkway/Livingston. Stay on JFK Parkway for approximately 3 miles to South Orange Avenue (Route 510). Make a left at traffic light onto South Orange Avenue. Continue straight, past the Livingston Mall on the right (traffic light). South Orange Avenue becomes Columbia Turnpike. Proceed for approximately 1 ¼ miles to traffic light at Fernwood Drive. Turn right onto Fernwood Drive and proceed to 30 Columbia Turnpike. Look for first building on right.

### **From New Jersey Turnpike and New York City**

Take New Jersey Turnpike to Exit 15W to Route 280 West. Take Exit 4A for Eisenhower Parkway/Chatham. Stay on Eisenhower Parkway for approximately 5 miles to South Orange Avenue traffic light (just past Livingston Mall on left). Turn right onto South Orange Avenue (Route 510). South Orange Avenue becomes Columbia Turnpike. Proceed for approximately 1 ¼ miles to traffic light at Fernwood Drive. Turn right onto Fernwood Drive and proceed to 30 Columbia Turnpike. Look for first building on right.
